The NCS fund balance, as of June 30, 2010, totals \$2,217,409. The year-to-date operating surplus totals \$153,319. Note that the net unrealized gain/(loss) on investments is (\$63,686) for the period.

Income as of June 30, 2010, totaled \$150,271 and is primarily related to dues income of \$147,550. The Educational Fund of the NCS has a current balance of \$2,060,569.

As of June 30, 2010, NCS has one active money market operating account that is held at Merrill Lynch in Baltimore, MD. Robert W. Costos of Kelly Group is managing the account. This account is used for NCS general operating transactions and convention related transactions. As of June 30, 2010, the operating account (OA) has a balance of \$141,341.

NCS President Dr. Steven Siegel and Secretary Dr. Howard Winfield are working together to plan another outstanding NCS Annual Meeting in Chicago, Illinois. Their combined creativity and skillfulness will ensure another outstanding NCS Annual Meeting that will provide additional value to NCS members and meeting attendees. Local Arrangements Chair Dr. Tamra Lewis is working to ensure an excellent meeting site in Chicago and is anticipating everyone’s early registration and presence at the meeting.

## Federal Affairs Update

### State of the Fed – What Goes Up Must Come Down

“Doc fix” – this phrase has become ingrained in the American people this last year. The recent stopgap passed in Congress on June 24th will stave off cuts to physician reimbursements through the end of November (just about a month after the 2010 mid-term elections). This short-term fix, the third one since the cuts were originally supposed to go into effect January 1st, will increase doctor payment rates by 2.2 percent. While this fix was necessary, it does nothing to address the problem that has been plaguing physicians for years. Ironically, the same day that the President signed the short-term fix into law, CMS released their new payment rule that would cut reimbursement rates by another 6.1 percent in 2011. If nothing is done, doctors are facing a total of 27 percent in cuts to their payments.

Patients’ access to care is not just a talking point being spouted by proponents of a more comprehensive fix, but is looking to become reality unless Congress stops the political pandering, and steps up and does what they were sent to Washington to do. The bottom line is doctors will no longer afford to see Medicare patients. I have received multiple phone calls over the past year from concerned physicians who are already restricting the number of Medicare patients in their practices. Now they want to know how to opt out of the program all together.

Reversing the planned pay cuts was something leaders on both sides maintained to favor, but the doc fix became stalled in a political battle over a \$118 billion package that included extending jobless benefits plus cash assistance to state governments for their Medicaid programs.

This political infighting is damaging to physicians and the patients they have dedicated their lives to serving. “Short-term patch,” “Kicking the can down the road” – these are phrases we have heard over and over again. Well, I have a new phrase Congress should take note of, “Dereliction of duty.” Members of Congress are sent to Washington to represent the needs of their constituency. They have NOT done this. It’s time we all, patients and doctors, stand hand-in-hand and hold them accountable.

### States Responding to Federal Health Reform

Implementation of key provisions of the Patient Protection and Affordable Care Act, signed March 23, 2010, by President Obama, greatly depends on action by state legislators and governors in each of the 50 states.

At least 39 states took action to challenge the law itself. Four states approved legislation to limit or oppose the federal law (Virginia, Georgia, Idaho and Utah). Four others will send the issue to voters in form of ballot referenda (Arizona, Florida, Missouri and Oklahoma). Similarly, Attorneys General in at least 20 states will challenge the federal law on constitutional grounds.

Many other states are building an infrastructure to apply the law. These efforts include the appointment of “implementation task forces” as well as amendments to current state law. In Michigan, Governor Jennifer Granholm (D) issued Executive Order No. 2010-4 to establish a Health Insurance Reform Coordinating Council, while Maryland Senate Bill 57 (signed by Governor April 13, 2010) requires insurers to allow young people up to the age of 26 to remain on their parents’ plan and bans lifetime caps on coverage. The California Legislature, one of the few bodies that meets year-round, continues to consider a number of bills to implement the new law’s broader Medicaid expansion and health insurance exchange requirements (AB1595, SB900).

However your state responds, however the courts decide and however future Congresses act, we will serve as your patients’ and practice’s advocate.

### Legislatures Up for Grabs

Political party control of legislative chambers in at least 18 states may switch hands this fall according to an analysis by *Governing*, a publication that covers state policy and politics.

The number of states in play is the highest since at least 2002 and control will have a direct impact on redistricting, an influential process that takes place only once every 10 years.

*Governing’s* Louis Jacobson asserts that Democrats must work hard to maintain leadership in 21 chambers, while Republicans will closely watch four. Jacobson reports that this disparity could increase in the coming months given dissatisfaction with Democratic control of Congress and the White House – one factor in the Democrats’ favor-division within the Republican Party amongst tea party and establishment activists.
